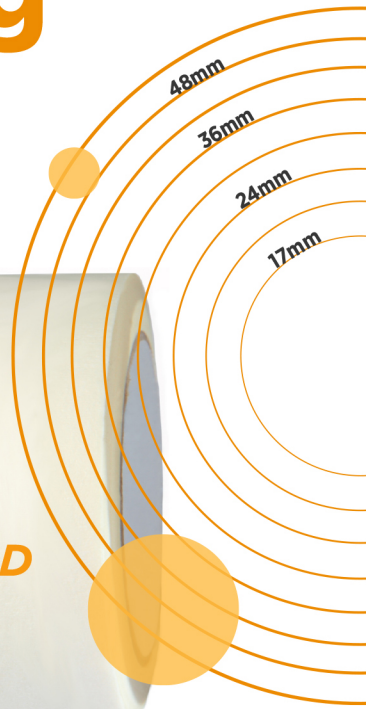

## Custom Master Rolls conversion

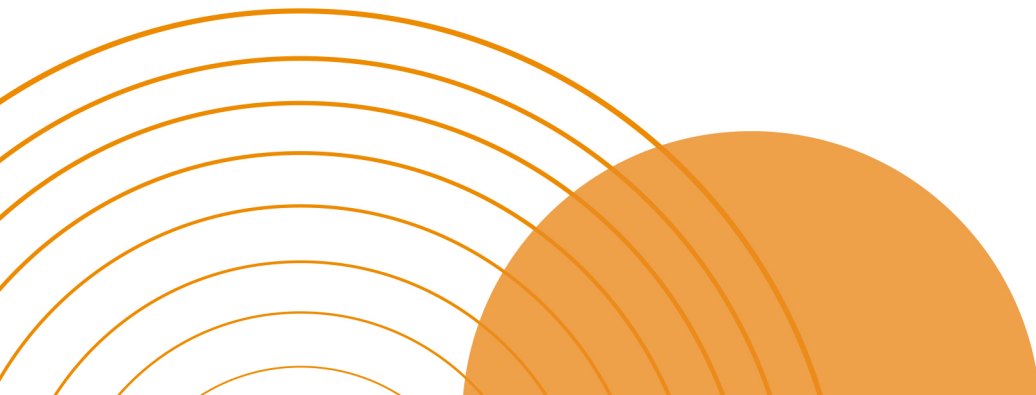
With the capability of reducing a larger master roll down to 17mm depending on the type of material.

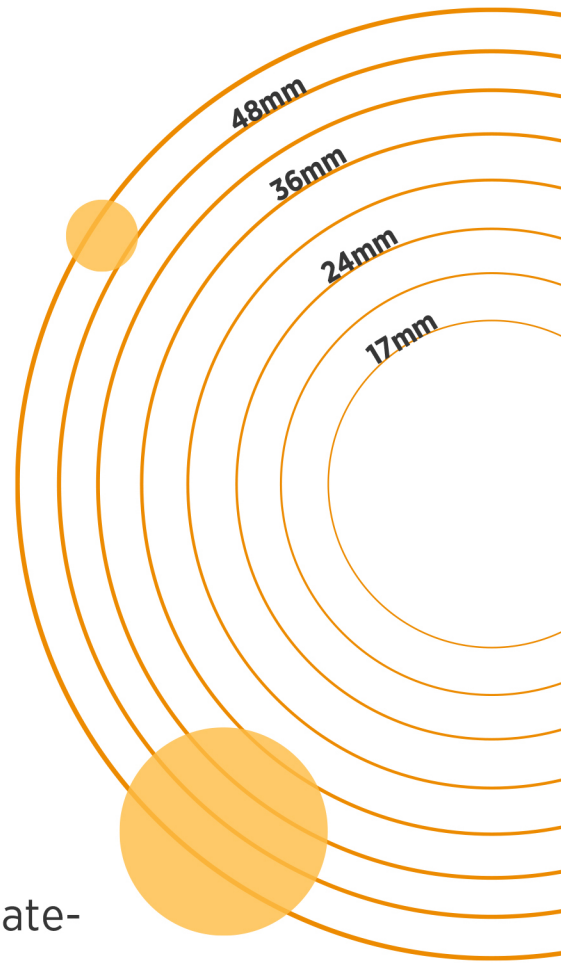

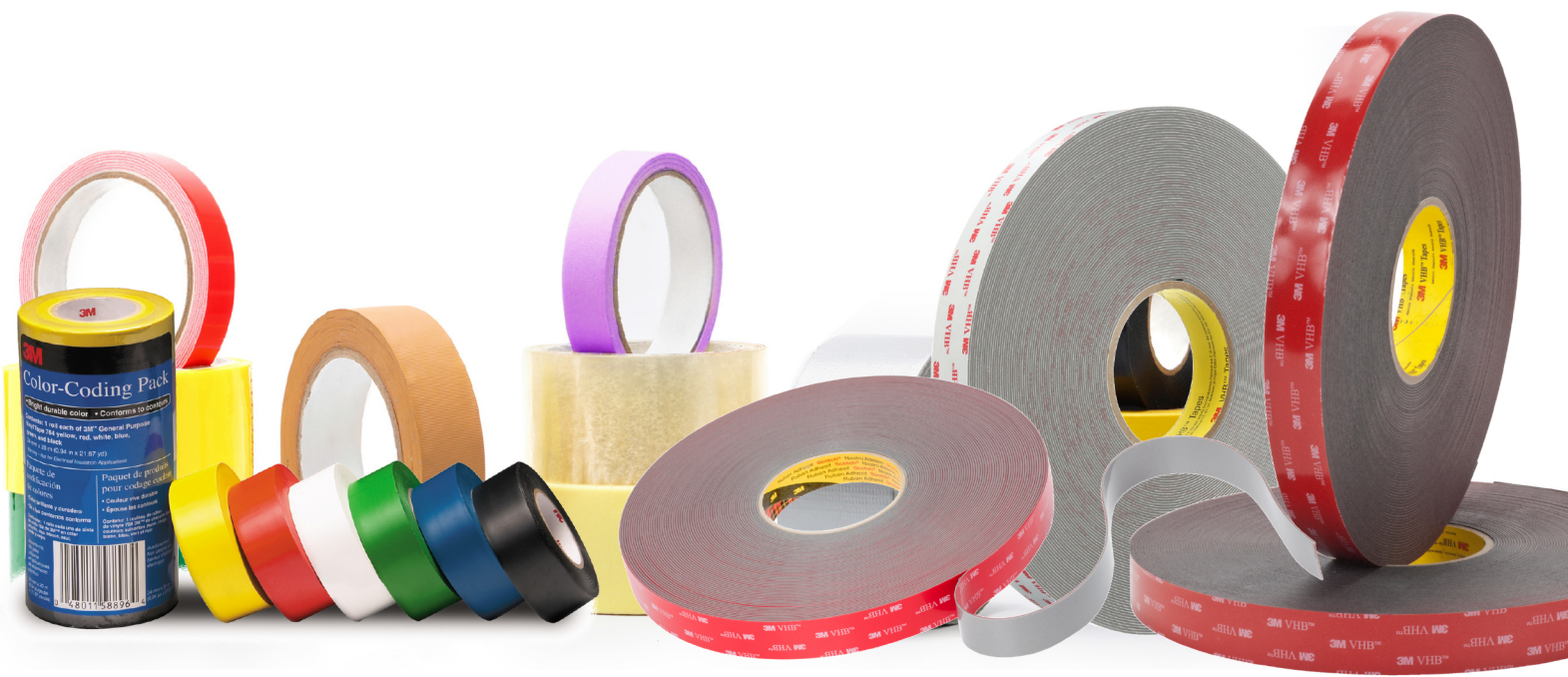

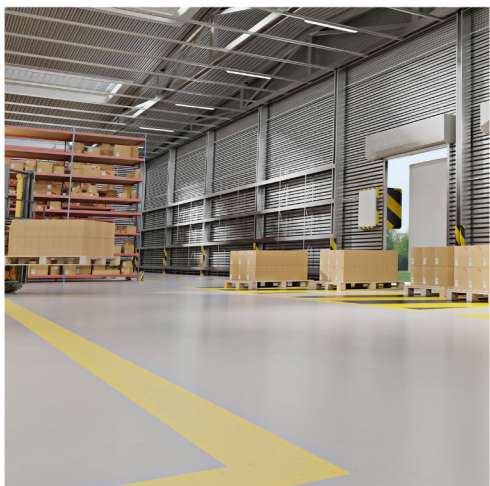
